



# Vostok New Ventures' Privacy Policy

Vostok New Ventures Ltd (together with its subsidiaries hereinafter referred to as "Vostok New Ventures") recognizes the importance of data protection and is committed to maintaining appropriate safeguards as required by applicable laws and regulations to ensure the integrity and security of your personal data. This privacy policy sets out how Vostok New Ventures may process your personal data.

## **Collection of personal data**

Vostok New Ventures collects and processes personal data that is provided in connection with your business relationship with Vostok New Ventures. Personal data may also be collected when you subscribe for press releases, newsletters or other information or when you register for capital markets days, seminars or similar events. Personal data may also be collected from third-party sources, e.g. as part of Vostok New Ventures' investment processes, or from publicly available records. Personal data collected and processed by Vostok New Ventures includes name, business-related contact details, information on your role and details of the company or organization that you represent.

## **Purposes of processing your personal data**

Vostok New Ventures processes personal data for business-related matters and for administrating and maintaining agreements and business relations with Vostok New Ventures' customers, suppliers and business partners as well as with shareholders and other stakeholders. Personal data may also be processed in order to manage Vostok New Ventures' investments and to send press releases, newsletters and invitations to capital markets days, seminars and similar events. When processing personal data for these purposes, Vostok New Ventures relies on legitimate interests. Vostok New Ventures has a strong interest in maintaining business relationships with other companies and organisations and only processes your business-related information as a representative or contact person of such company or organization.

## **Processing of your personal data**

Vostok New Ventures may disclose your personal data to competent authorities, group companies, business partners or service providers for the purposes described above. If a business partner or a service provider is located in a country outside the EU/EEA, your personal data may be transferred to a country that does not have data protection laws equivalent to ours. In those cases, Vostok New Ventures will put in place appropriate safeguards to protect your personal data in connection with the transfer. ### **Retention of personal data**

Vostok New Ventures retains personal data as long as there is a business relationship with the company or organization that you represent or otherwise as long as it is necessary to fulfil the purpose of the processing. Personal data will also be retained as long as required by applicable laws, regulations or decisions by authorities. You may at any time unsubscribe from receiving press releases, newsletters and similar information and your information will thereafter no longer be retained for such purposes.

### **Information Rights**

You are entitled to request information on the personal data that we hold about you and how it is used. You may also request that any inaccurate personal data be corrected. You may also be entitled under applicable law to request that your personal data be erased or that the processing of your personal data be limited, to object to the processing of your personal data and to request a transcript of your personal data in a machine-readable format.
