Vostok New Ventures Ltd. ("VNV Bermuda" or the "Company") is soliciting votes with respect a scheme of arrangement (the "Scheme") implemented under Bermuda law (as may be amended from time to time, the "Scheme").

You have been provided with this Proxy Card as part of the Instruction Package which contains an explanatory statement ("Explanatory Statement") relating to the Scheme. Capitalized terms used but not otherwise defined herein shall have the meanings set forth in the Explanatory Statement. YOU ARE ENCOURAGED TO READ THE MATERIALS CONTAINED IN THE INSTRUCTION PACKAGE IN FULL. The Scheme, if implemented will materially affect the rights of holders of Swedish Depositary Receipts representing common shares of the Company.

Your rights are described in the Explanatory Statement, which includes the Scheme. This Proxy Card may not be used for any purpose other than to appoint a proxy to cast votes to accept or reject the Scheme at the Scheme Meeting. If you believe you have received this Proxy Card in error, please contact the Company immediately.

¹ "Eligible SDR Holder" means a holder of Swedish Depositary Receipts representing common shares of the Company and listed in the register of Swedish Depositary Receipt holders kept by Euroclear Sweden AB as of 6 May 2020 (the "Record Date").

You should review the Explanatory Statement and the Scheme in their entirety before you vote. You may wish to seek legal advice concerning the Scheme.

The Bermuda Court may sanction the Scheme and bind you if the Scheme is accepted by SDR Holders of at least seventy five percent by value and a majority in number of those SDR Holders voting (in person or by proxy) at the Scheme Meeting. The terms of the Scheme provide that the Scheme will not be effective until such time as the Plan is confirmed by the Bermuda Court.

To have your vote counted at the Scheme Meeting, you must either (i) attend the Scheme Meeting (the time and venue of which is as per the Notice of Scheme Meeting included in the Instruction Package) or (ii) appoint a proxy to attend the Scheme Meeting and vote on your behalf by completing this Proxy Card pursuant to the instructions provided herein and indicating how your proxy should vote at the Scheme Meeting.

Please note that SDR Holders whose depository receipts have been registered in the name of a bank or securities institute must re-register their depository receipts in their own name to vote. Instructions for this are included in the notice convening the Scheme Meeting.

INSTRUCTIONS FOR COMPLETING THIS PROXY

1. The Company is soliciting the votes of SDR Holders with respect to the Scheme. Capitalized terms used in the Proxy or in these instructions (the “**Proxy Card Instructions**”) but not otherwise defined therein or herein shall have the meaning set forth in the Explanatory Statement, a copy of which also accompanies the Proxy.
2. To ensure that your vote is counted, you must **EITHER** complete the Proxy, appoint a Proxy and take the following steps: (a) make sure that the information required by Item 1 above has been correctly inserted; (b) select a proxy in Item 2 above; (c) clearly indicate how your proxy should vote your SDRs in Item 3 above; (c) read and certify the information contained in this Proxy, including but not limited to the statements in Item 4 above; and (e) sign, date and return an original of your Proxy in accordance with paragraph 3 directly below **OR** attend the Scheme Meeting in person.
3. **Submission of Proxy Election and Votes:** Your proxy election and vote must be incorporated in a Proxy that is returned to the Voting and Claims Agent so as to be **actually received** by the Voting and Claims Agent on or before the Voting Deadline, which is 10 May 2020.
4. If a Proxy is received by the Voting and Claims Agent after the Voting Deadline, it will not be counted and you must attend the Scheme Meeting in person to vote your SDRs. Additionally, the following Proxies will **NOT** be counted:
 - any Proxy that is illegible or contains insufficient information to permit the identification of the SDR Holder;
 - any Proxy cast by a person or entity that does not hold SDRs;
 - any Proxy that is properly completed, executed and timely filed, but does not indicate an appointment of a proxy;
 - any unsigned Proxy; or
 - any Proxy not cast in accordance with the procedures set out in the Explanatory Statement as approved by the Bermuda Court.
5. The method of delivery of Proxies to the Voting and Claims Agent or your Nominee is at the election and risk of each SDR Holder. Except as otherwise provided herein, such delivery will be deemed made to the Voting and Claims Agent only when the Voting and Claims Agent **actually receives** the Proxy. Instead of effecting delivery by first-class mail, it is recommended, though not required, that SDR Holders use an overnight or hand delivery service. In all cases, SDR Holders should allow sufficient time to assure timely delivery.
6. You must appoint a proxy and instruct them to vote in respect of the entirety of your SDRs and may not split your SDRs for the purposes of this Proxy Card.
7. The Proxy is not a letter of transmittal and may not be used for any purpose other than to appoint a Proxy to vote at the Scheme Meeting.
8. **Please be sure to sign and date your Proxy.** If you are signing a Proxy in your capacity as a trustee, executor, administrator, guardian, attorney in fact, officer of a corporation or otherwise acting in a fiduciary or representative capacity, you must indicate such capacity when signing and, if required or requested by the Voting and Claims Agent or the Company, must submit proper evidence to the requesting party to so act on behalf of such SDR Holder. In addition, please provide your name and mailing address if it is different from that set forth on the attached mailing label or if no such mailing label is attached to the Proxy.
